Guillermo Barnés García is an ITAM graduated economist. He holds post-graduate studies in economics from Columbia University, New York. He is a specialist in macroeconomic and banking-financial topics.

He has worked in the public service in the Finance and Public Credit Department, where he held the positions of Chief of Planning Unit from 1992 to 1993 and as Chief of Staff from 1995 to 1996. He was General Director of the Patronage of National Savings in 1994 and between 2001 and 2015 was Commissioner of the Trust to Support Savings Banks. From 1997 to 2000, he was Federal Deputy and Secretary of the Programming and Budget Commission at the Chamber of Deputies.

Mr. Barnés has taught at ITAM, El Colegio de Mexico, and INAP. He has several publications on the Mexican banking system, public spending, and privatization processes.

His research topics include economic growth, public debt, monetary policy, rare macroeconomic disasters, and the interplay between religion and political economy.

Donald J. Boudreaux is a professor of economics at George Mason University in Fairfax, Virginia. During the spring 1996 semester, he was an Olin Visiting Fellow in Law and Economics at the Cornell Law School. His PhD in economics is from Auburn University (1986) and his law degree is from the University of Virginia (1992).

He has lectured, in the United States, Canada, Latin America, and Europe, on a wide variety of topics, including the nature of law, antitrust law and economics, and international trade. He is published in the *Wall Street Journal*, *Investor's Business Daily*, *Regulation*, *Reason*, *Ideas on Liberty*, the *Washington Times*, the *Journal of Commerce*, the *Cato Journal*, and several scholarly journals such as the *Supreme Court Economic Review*, *Southern Economic Journal*, *Antitrust Bulletin*, and *Journal of Money, Credit, and Banking*.

Ignacio Briones is the former Minister of Finance, Republic of Chile (2019-2021).

Previously he was Dean of the School of Government (2014-2019) and Associate Professor of Economics at Adolfo Ibáñez University, Chile. His research interests focus on economic and financial history.

Between 2013 and 2014, he was Chile's Ambassador to the Organization for Economic Cooperation and Development (OECD). From 2010 to 2013, he served as International Finance Coordinator in the Ministry of Finance and as Executive Secretary of the Financial Stability Board.

He has also served as Director of Codelco and as a member of the board of private companies.

Mr. Briones is the co-founder (2012) of Horizontal, a Chilean think tank rooted in liberal ideas, and former President of the Chilean Public Policy Society.

He also ran as a presidential candidate in the primary elections of Chile Vamos, the center-right coalition in power under President Piñera's Administration (2018-2022).

He holds a Ph.D. in Economics from the Institut d'Etudes Politiques de Paris (Sciences Po) and a B.A. in Business Administration, an M.A. in Financial Economics, and an M.A. in Political Science from Pontificia Universidad Católica de Chile.

James Bullard, former president of Federal Reserve Bank of St. Louis and one of the nation's foremost economists and respected scholar-leaders, was chosen in July 2023 as the inaugural dean of the reimagined Mitch Daniels School of Business at Purdue University.

Bullard is charged with inspiring, further developing and implementing Purdue's reimagined approach to a top-ranked business school across undergraduate, graduate, executive and research programs, preparing tomorrow's business leaders and entrepreneurs in the Daniels School that is grounded in the principles of free enterprise, free market economy in generating opportunities and prosperity, and in the hallmarks of a well-rounded Purdue education and with a particular emphasis on tech-driven, analytics-based business success.

Serving 15 years as the sitting president and chief executive officer of the Federal Reserve Bank of St. Louis, Bullard earned significant praise and accolades for his long-standing leadership and innovative thinking as part of the Federal Open Market Committee (FOMC) in guiding the direction of U.S. monetary policy. A noted economist and scholar, Bullard had been the longest-serving Federal Reserve Bank president in the country and ranked as the seventh-most influential economist in the world in 2014.

Charles W. Calomiris is the Henry Kaufman Professor of Financial Institutions at Columbia Business School, Director of the Business School's Program for Financial Studies and its Initiative on Finance and Growth in Emerging Markets, and a professor at Columbia's School of International and Public Affairs.

His research spans the areas of banking, corporate finance, financial history and monetary economics. He is a Distinguished Visiting Fellow at the Hoover Institution, a Fellow at the Manhattan Institute, a member of the Shadow Open Market Committee and the Financial Economist Roundtable, and a Research Associate of the National Bureau of Economic Research.

Charles W. Calomiris has served on numerous committees, including the Advisory Scientific Committee of the European Systemic Risk Board, the U.S. Congress's International Financial Institution Advisory Committee. He serves as co-managing editor of the *Journal of Financial Intermediation*.

He received a B.A. in economics from Yale University, Magna Cum Laude, and a Ph.D. in economics from Stanford University. He holds an honorary doctorate from the University of Basel.





## AGUSTÍN CARSTENS

Agustín Carstens is a Mexican economist of international renown and one of the most influential figures in global monetary and financial policy. Since December 1, 2017, he has served as General Manager of the Bank for International Settlements (BIS), the institution that acts as the central bank for central banks.

Carstens was Governor of the Bank of Mexico from 2010 to 2017, a period during which he strengthened the central bank's credibility and Mexico's macroeconomic stability. As a member of the BIS Board of Directors from 2011 to 2017, he chaired the Global Economy Meeting and the Economic Consultative Committee between 2013 and 2017. He also served as Chair of the International Monetary and Financial Committee (IMFC) of the International Monetary Fund (IMF) from 2015 to 2017.

He began his professional career in 1980 at the Bank of Mexico. From 1999 to 2000, he was an Executive Director at the IMF, later serving as Deputy Minister of Finance of Mexico (2000–2003) and as Deputy Managing Director of the IMF (2003–2006). From 2006 to 2009, he was Mexico's Minister of Finance and Public Credit.

Agustín Carstens has been a member of the Financial Stability Board since 2010 and of the Group of Thirty (G30), a forum that brings together leading financial and academic figures worldwide. He holds a master's degree and a Ph.D. in Economics from the University of Chicago, training that has shaped his technical approach and his commitment to monetary and financial stability.

Carlos Carvalho is President of the University of Austin. Prior to assuming this role, he spent 15 years as a professor at the McCombs School of Business at the University of Texas at Austin, where he held the La Quinta Centennial Professorship and founded the Salem Center for Policy.

A native of Brazil, Dr. Carvalho earned his Ph.D. in Statistics from Duke University and has also taught at the University of Chicago Booth School of Business. His research focuses on Bayesian statistics applied to complex, high-dimensional problems, with applications in economics, genetics, and public policy.

At the University of Austin, he is currently responsible for the university's academic and institutional development.

Vittorio Corbo is President of Vittorio Corbo & Associates, member of the MIT Sloan Latin American Advisory Council and of the International Advisory Council of the Center for Social and Economic Research (CASE) in Warsaw, Poland.

He was President of the Central Bank of Chile (2003-2007) and member of the Chief Economist Advisory Board of the World Bank and of the Advisory Committee of the Capital Market Department of the IMF.

In the academic world he was Assistant, Associate and Full Professor of Economics at Concordia University in Montreal, Canada (1972-1981), Professor of Economics at the Pontificia Universidad Católica de Chile (1981-1984 and 1991-2003), and Professorial Lecturer in Economics at Georgetown University in Washington, DC (1985-1991). He was also a Senior Research Associate at CEP ((2008-2017), President of the Latin American Chapter of the Econometric Society, Vice-President of the International Economic Association and member of the Council of the Econometric Society.

He also served in several managerial positions at the World Bank in Washington, DC (1984-1991) where his last job was as Chief of the Macroeconomic Adjustment and Growth Division.

In recent years he was the President of a Chilean Commission to update and strengthen de fiscal rule (2010), member of a Presidential Commission against Corruption and Conflicts of Interests (2015), member of a working group on the modernization of the banking law (2015), and member of the Council on Comprehensive Development appointed by President Piñera (2018).

Simeon Djankov is currently a senior fellow at the Peterson Institute for International Economics. Until April 2020, he held various positions at the World Bank including Director, Development Policy in DEC, Senior Director in the Office of the Chief Economist (DECCE); Executive Director, Financial Markets Group, at the London School of Economics.

He also served as Deputy Prime Minister and Minister of Finance, Republic of Bulgaria for 2009 to 2013; and as Chairman of the Board, European Bank for Reconstruction and Development in 2013-2014. Early in his career, he joined the World Bank Group as a Young Professional in 1997 and held other positions including founding the Doing Business project. Mr. Djankov holds an M.A. and a Ph.D. in Economics from the University of Michigan.

Everardo Elizondo has worked in the private, public, and academic sectors. From 2000 to 2008, he was deputy governor in the Board of the Banco de México. He is Professor of Economics at the Tecnológico de Monterrey, EGADE business school.

Everardo was the founder, director, and professor of public economics at the Graduate School of the Economics faculty at the Universidad Autónoma de Nuevo León (UANL). From 1982 to 1983, he was a visiting scholar at the Latin American Studies Institute of the University of Texas in Austin.

He began his career in the Serfín Financial Group Department of Economic Studies, a bank known today as Banco Santander. Later, he was director of Economic Studies for Grupo Alfa. He was founding director of Index Applied Economics, a consulting firm, and Chief Economist at Grupo Financiero Bancomer.

For several years, he has been a regular columnist on economic and financial topics for the group of newspapers associated with *Reforma*. He is a member of the external Board of Advisors of the Universidad Autónoma de Nuevo León and Coca-Cola FEMSA Advisory Board.





## PHIL GRAMM

Senator Gramm joined Lone Star Global Acquisitions as Vice Chairman in December of 2012. He served as Vice Chairman of UBS Investment Bank from December 2002 to December 2011. At UBS, he provided senior leadership for such landmark IPOs as Visa, the Bank of China, the China Merchants Bank and LG Philips in Korea. He was instrumental in the follow-on equity offering for the Industrial and Commercial Bank of China, the privatization of Telstra in Australia and the sale of 20% of Akbank in Turkey to Citibank.

Senator Gramm served six years in the US House of Representatives and eighteen years in the US Senate. His legislative record includes the Gramm-Latta Budget, which reduced federal spending, rebuilt national defense and mandated the Reagan tax cut, and the Gramm-Rudman Act, which placed the first binding constraints on the federal deficit. As Chairman of the Banking Committee, Senator Gramm steered through legislation modernizing banking, insurance, and securities law, which had been languishing in Congress for 60 years. Dodd-Frank did not repeal Gramm-Leach-Bliley but expanded the law by requiring systemically significant non-banks to become Financial Services Holding Companies under Gramm-Leach-Bliley.

Gramm is a Visiting Scholar at the American Enterprise Institute. He holds a Ph.D. from the University of Georgia in economics and has taught at Texas A&M University for twelve years. He has published numerous articles and books on subjects ranging from monetary theory and policy to private property and the economics of mineral extraction.

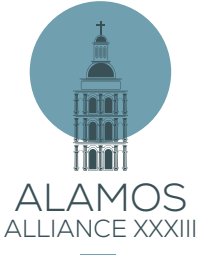
